Copperstone Community Development District  
Capital Improvement Revenue Refunding Bonds, Series 2018**

**1.0 Overview**

The Copperstone Community Development District (“Copperstone” or “District”) was created on November 13, 2006. The District encompasses approximately 261 acres in Manatee County. The District completed its capital improvement plan (“CIP”) for the 622 residential units. The area is improved at this time. The Copperstone Community Development District Report by District Engineer, dated March 20, 2007 (the “Engineer’s Report”) provides a description of the area and a detailed CIP.

This Preliminary Supplemental Assessment Report (“Supplemental Report”) provides a methodology to allocate the bond refunding proceeds among the 622 residential units in Copperstone that receive a special benefit from the CIP installed in Copperstone. It is the District’s debt-funded capital infrastructure improvements that allowed the development of property in the District. By making development of property within Copperstone possible, the District creates benefits to these properties.

The methodology described here allocates the District’s debt to properties based upon the benefits each receives from the infrastructure program. In this case the properties receiving benefit are the 622 residential units within the District. This report is designed to conform to the requirements of Chapters 190 and 170, F.S. with respect to special assessments and is consistent with our understanding of the case law on this subject.

**1.1 Background and Land Use Plan for Copperstone**

The Board of Supervisors (“Board”) of the District had previously approved the Final Special Assessment Allocation Report for the District, dated March 27, 2007 (“Final Report”). The Final Report established a methodology the District followed to allocate the costs of the District’s CIP among the benefiting properties planned for the District. The scope of the CIP is set forth in the Engineer’s Report. A portion of the costs of the District’s CIP were funded with the proceeds of the Series 2007 Special Assessment Bonds (“Series 2007 Bonds”). The intended use of proceeds of the District’s Series 2007 Bonds, at the time of issuance, are found below in Table 1.

The 2007 Final Report allocated Series 2007 Bonds and assessments to developed units on an equivalent assessment unit (“EAU”) basis. The unit types and Series 2007 Bond principal and annual debt service assessments for the development planned for the District at the time of the adoption of the Final Report are found below in Table 2.

## 1.2 Purpose

The lands within the District have undergone substantial development since the time of the issuance of the Series 2007 Bonds. All 622 residential lots have been platted and/or developed as residential units within the District to date.

The project’s development, combined with other more general economic factors provide the District with the opportunity to refund its Series 2007 Bonds at more favorable terms than was available at the time of issuance. Thus, the Capital Improvement Refunding Bonds, Series 2018 (“Series 2018 Bonds”) will be issued by the District in the aggregate principal amount of \$5,770,000 to refund the \$5,550,051 aggregate principal amount of outstanding

Series 2007 Bonds. This Supplemental Report is intended to complement the current Final Report with respect to the allocation of the debt service to be imposed by the issuance of the Series 2018 Bonds.

### 1.3 Requirements of a Valid Assessment Methodology

Valid special assessments under Florida law require two things. First, the properties assessed must receive a special benefit from the improvements paid for via the assessments that exceeds the burden of the debt placed upon them. Second, the assessments must be fairly and reasonably allocated to the properties being assessed.

If these two characteristics of valid special assessments are adhered to, Florida law provides wide latitude to legislative bodies, such as the District's Board of Supervisors in approving special assessments. Indeed, Florida courts have found that mathematical perfection is probably impossible, but if reasonable people disagree the assessment will be upheld. Only if the Board was to act in an arbitrary, capricious or grossly unfair fashion would its assessment methods be overturned.

### 1.4 Special Benefits and General Benefits

Capital Infrastructure improvements included in the CIP create both: (1) special benefits to Copperstone and (2) general benefits to properties outside Copperstone. However, as discussed below, these general benefits are incidental in nature and are readily distinguishable from the special benefits which accrue to Copperstone. The CIP described in the District Engineer's Report enables Copperstone to be developed. Without the CIP, there would be no infrastructure to support development of Copperstone.

There is no doubt that the general public, and property owners outside Copperstone, will benefit from the provision of the CIP. However, these benefits are incidental to the CIP, which is designed solely to meet the needs of Copperstone. Lands outside Copperstone, including in the benefiting area, do not depend upon the CIP to obtain, or to maintain, their development entitlements. This fact alone clearly distinguishes the special benefits which developable property in Copperstone receives compared to those lying outside of the boundaries of Copperstone.

Finally, as shown in Table 3, the total cost of the CIP is \$16,157,151. There are 261.28 assessable acres within the District. Therefore, the average cost per assessable acre in the District is \$72,628 on a financed per acre basis. According to data from the Manatee County Property Appraiser ("PA"), the fair market value of the agricultural land within a five-mile radius of Copperstone currently averages \$18,703 per acre. Therefore, as illustrated in the table immediately below, the total cost of the land with the proposed improvements implemented is approximately \$91,331 per acre.

Based on the final development plan of 622 residential units and current just value as provided by the Manatee County Property Appraiser of all of the homes within Copperstone, the average value for a residential unit within Copperstone is \$200,404. The typical relationship between the total price of a new home and its finished lot is 25%. So, the average home lot in the District is expected to have a retail value of \$50,101.

The land use plan has a gross residential density of 2.38 units per assessable acre. Therefore, the average value per acre for properties developed into residential lots is \$119,270. Thus, the estimated net special benefit to District lands is \$27,939 per acre. In other words, the installation of the CIP will increase the market value of the land within the District in excess of the cost of the assessments.

## 2.0 Assessment Methodology

### 2.1 Overview

The assessment methodology is a process by which the District will allocate the costs associated with its improvement program to properties in the District benefiting from the improvements. The allocation is based upon the benefits that each property receives.

## 2.2 The District's CIP for Copperstone and Series 2018 Bonds

The CIP costs are summarized in Table 4. The Engineer's Report reports a total project cost of \$16,157,151. The CIP estimate excludes financing costs and interest expenses.

Per the Series 2007 Bonds, only a portion of the total CIP costs were funded by District debt. Based on the final cost of the CIP and original 2007 Series Bonds, the Series 2018 Bonds associated with the refunding are summarized herein. Table 5 provides a summary of the \$5,515,000 bond refunding.

### 2.3 Allocation to Benefiting Properties – The Supplemental Methodology

The discussion offered herein illustrates the process by which this report will allocate assessments levied to pay indebtedness incurred to support the refunded portion of the CIP. As noted above, as long as two basic principles are adhered to, Florida law allows the Board of the District great latitude in determining the appropriate methodology to allocate the costs of the CIP to benefiting properties within the District. The two principals are: (1) the properties being assessed must receive a special benefit from the CIP and (2) the assessments allocated to each property must be fairly and reasonably apportioned among the benefiting properties. In allocating special assessment costs to benefiting property Florida governments have used a variety of methods including, but not limited to, front footage, area, trip rates, equivalent residential units, dwelling units, acreage, and value.

As shown in Table 6, Copperstone includes 622 residential units, of which 118 are townhomes and 504 single family residential units. However, at the time of the bond refunding, three units have prepaid their respective Series 2007 Bonds debt assessments. The 619 remaining units will be allocated the Series 2018 Bonds.

The 2007 Final Report allocated Series 2007 Bonds and assessments to developed units on an EAU basis. This Supplemental Report applies a methodology consistent with the 2007 Final Report for the Series 2018 Bonds with respect to the allocation of assessments via EAU. Table 7 summarizes the EAU allocation for the Series 2018 Bonds.

#### 2.4 Allocation of Refunding Costs to Properties within Copperstone

As shown in Table 8, the Series 2018 Bonds associated with the refunding total \$5,515,000. The costs associated with the CIP infrastructure refunding will be allocated using the methodology outlined in Table 7 (i.e. by EAU). This section of the methodology focuses on the allocation of costs within the District. Annual assessments were based on the maximum annual debt service (“MADS”) associated with the Series 2018 Bonds. The estimated gross annual assessment per unit amount is based on the bond sizing, and it includes a 7% gross up to defray administrative costs for collection by Manatee County and an allowance for early payment of assessments.
